

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.amydifrancia.com, and Amy Di Francia Mental Health and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Amy Di Francia Mental Health include www.amydifrancia.com. The Amy Di Francia Mental Health website is a eCommerce site. By using the Amy Di Francia Mental Health website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Amy Di Francia Mental Health may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Amy Di Francia Mental Health's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sharing Information with Third Parties
